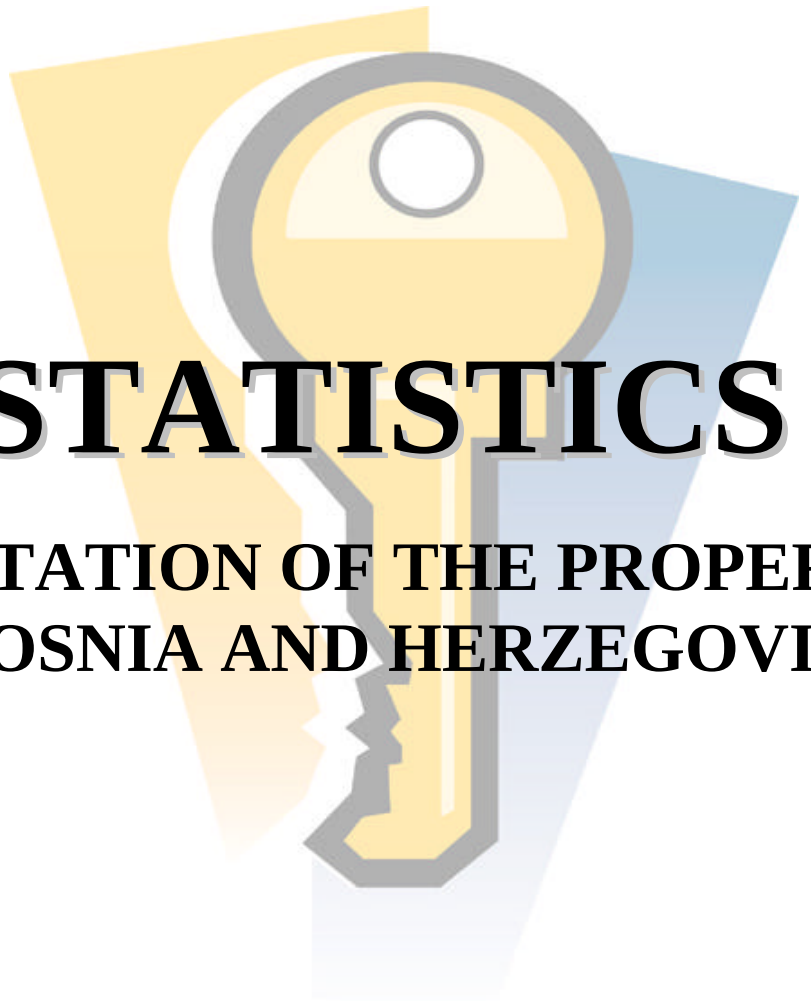




STATISTICS

IMPLEMENTATION OF THE PROPERTY LAWS IN BOSNIA AND HERZEGOVINA

31 January 2004

EXPLANATORY NOTE

- These statistics reflect the implementation of the property laws in Bosnia and Herzegovina.
- These statistics are collected every month by the staff of OSCE, UNHCR and OHR in the field on the basis of information provided to them by the municipal housing authorities/OMIs.
- **THE NUMBER OF CLAIMS** stated is equal to the total number of properties on which a claim and/or request for enforcement of a CRPC decision was filed with the municipal housing authorities.
- **THE NUMBER OF POSITIVE DECISIONS** stated is the number of decisions issued on contested / occupied property by the municipal housing authorities in favour of the claimant.
- **THE NUMBER OF NEGATIVE DECISIONS** stated is the number of rejected / refused decisions issued on contested / occupied property by the municipal housing authorities.
- **THE NUMBER OF CASES CLOSED** stated is the total number of properties that have been vacated and/or sealed and/or repossessed and/or the occupancy right holder or owner was notified that s/he can repossess.
- **THE IMPLEMENTATION RATIO** is the total number of closed cases divided by the total number of claims, given as a percentage.
- These statistics do not include information on claims, decisions and cases closed on uncontested/unoccupied property.
- In some municipalities, the current implementation ratio is lower or has only insignificantly increased from the implementation ratio at the end of 2002. In some municipalities there are also sudden increases and decreases. This is all due to the revision of case files, retroactive exclusion of destroyed properties and harmonization of statistics collecting methods, which are taking place country-wide.
- A new column on chronological order was introduced in the PLIP statistics since 1 January 2003 where each municipal housing office/OMI should state the filing date of the earliest claim submitted to the municipal authorities/OMIs which is still unsolved.
- In the column on chronological order the words CASES COMPLETED mean that the caseload was finalized, while PLI VERIFIED means that also the criteria for substantial completion of PLI have been fulfilled and PLIP Cell has confirmed it. - Please note that due to certain redefinitions in line with the amended PLIP Statistics Questionnaire introduced on 1 January 2003, whereby cases closed have been substituted for repossessions and the "claims total" incorporates all contested property, some further alterations have resulted.

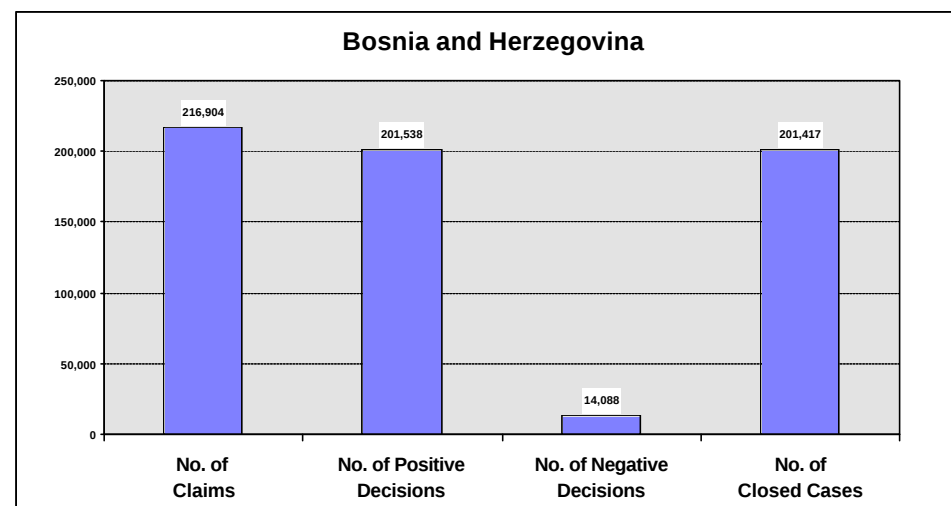
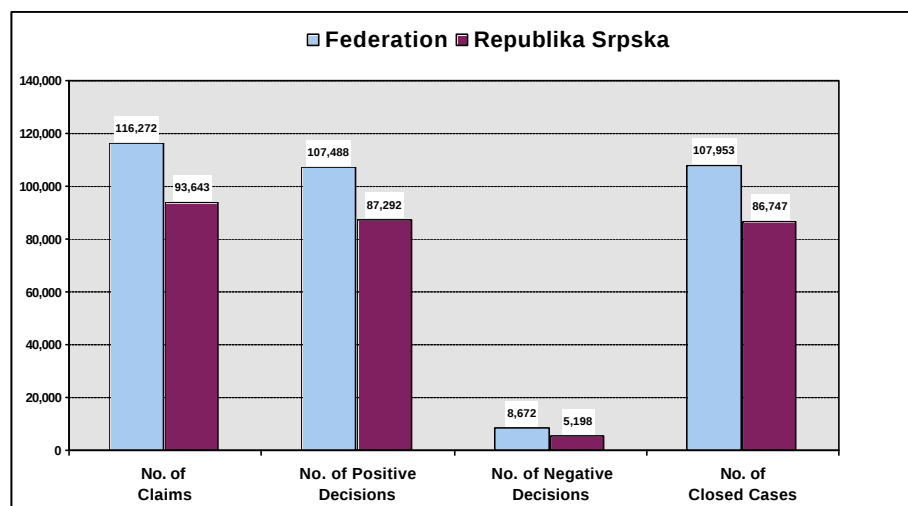
